Peter piloted a Martin P5M Marlin and was stationed in Bermuda (Squadron VP-45) where his role was to patrol our nation's coastline in search of Soviet submarines. He next became an instructor in the School of Pre-Flight at NAS Pensacola, Florida. In 1963, Peter was honorably discharged from the U.S. Navy with the rank of Lieutenant. After returning to Westchester with his family, Peter joined the New York Telephone Company/NYNEX in 1964. He retired after 30 years. Peter was also active in the Briarcliff community during his 45 years as a resident, serving as a Little League coach, league officer, vice president, and treasurer; a Boy Scout Webelo leader; a lector at St. Theresa's Church; and a volunteer at the Ossining Food Pantry. Peter was also a Briarcliff School Board Trustee for seven years, serving as president from 1980-81 and 1983-84. John Finn

Editor's note: Lt. Finn passed away May 27, 2010 at the age of 100. At the time of his death, he was the oldest survivor of the attack on O'ahu, Hawaii on December 7, 1941 and the oldest living Medal of Honor recipient. In addition, he is the only Aviation Ordnanceman awarded the Medal of Honor. John William Finn was a United States




Finn's wife Alice pins on the MOH, May 1942

Navy Chief Petty Officer who received the military's highest decoration, the Medal of Honor, for his actions during the attack on O'ahu in December 1941. As a Chief Aviation Ordnanceman stationed at Naval Air Station (NAS) Kaneohe Bay, he earned the medal by manning a machine gun from an exposed position throughout the attack, despite being repeatedly wounded. Born July 23, 1909 in Los Angeles, Finn dropped out of school after the seventh grade. He enlisted in the Navy in July 1926, shortly before his 17th birthday, and received recruit training in San Diego. After a brief stint with a ceremonial guard company, he attended

General Aviation Utilities Training at Naval Station Great Lakes, graduating in December. By April 1927 he was back in San Diego, having been assigned to NAS North Island. He initially worked in aircraft repair before becoming an Aviation Ordnanceman and working on anti-aircraft guns. He then served on a series of ships: USS LEXINGTON (CV-2), USS HOUSTON (CA-30), USS JASON (AC-12), USS SARATOGA (CV-3), and USS CINCINNATI (CL-6). After being promoted to Chief Petty Officer in 1936, he served with patrol squadrons in San Diego, Washington, and Panama. By December 1941, Finn was stationed at NAS Kaneohe Bay on the island of Oahu in the Territory of Hawaii. As a Chief Aviation Ordnanceman, he was in charge of 20 men whose primary task was to maintain the weapons of a PBY Catalina flying boat squadron, VP-14. On the morning of December 7, 1941, Finn was at his home, about a mile from the aircraft hangars, when he heard the sound of gunfire. Finn recalled how a neighbor was the first to alert him, when she knocked on his door saying; "They want you down at the squadron right away!" He drove to the hangars (seeing Japanese planes in the sky on the way) and found that the airbase was being attacked, with most of the PBYs already on fire. His men fought back by using the machine guns mounted in the PBYs, either by firing from inside the flaming planes or by detaching the guns and mounting them on improvised stands. One of the first things Finn did was take control of a machine gun from his squadron's painter. "I said, 'Alex, let me take that gun'...knew that I had more experience firing a machine gun than a painter." Finn then found a movable platform used for gunnery training, attached the .50 caliber machine gun to it, and pushed the platform into an open area from which he had a clear view of the attacking aircraft. He fired on the Japanese planes for the next two hours, even after being seriously wounded, until the attack had ended. In total, he received 21 wounds, including a bullet through the foot and an injury which caused him to lose feeling in his left arm. "I got that gun and I started shooting at Jap planes," Finn said in a 2009 interview. "I was out there

shooting the Jap planes and just every so often I was a target for some," he said, "In some cases, I could see [the Japanese pilots'] faces." Despite his wounds, he returned to the hangars later that day, after receiving medical treatment, and helped arm the surviving American planes. For these actions, Finn was formally presented with the Medal of



Honor September 14, 1942, by Adm. Chester Nimitz. The ceremony occurred in Pearl Harbor on board USS ENTERPRISE (CV-6). During the remainder of World War II, he served as a Limited Duty Officer Ensign and eventually as a Lieutenant with Bombing Squadron VB-102 and aboard USS HANCOCK (CV-19). He retired from the Navy in the rank of Lieutenant in September 1946. From 1946 until shortly before his death, Finn resided on a 90- acre ranch in Live Oak Springs, near Pine Valley, Calif. He and his wife became foster parents to five Native American children, embraced by the Campo Band of Diegueño Mission Indians, a tribe of Kumeyaay people in San Diego. After his death he was buried at the Campo Indian Reservation cemetery with full military honors. Written by CAPT David Lepard, Force Weapons, Commander, Naval Air Forces

Financial Report. President Buck Jones proposed that the financial report be submitted for approval by the Treasurer, PJ Imhof. It was motioned, seconded and approved unanimously. The financial report appears at the conclusion of the Business Meeting minutes.

Membership/Advertising. President Buck Jones led a discussion on membership. This continues to be an issue. All members are encouraged to seek new members for the VP-45 Association.

Website Maintenance and Web Master Position. President Buck Jones recommended that we add the office of "Webmaster" to our By-Laws. Currently, Steve Riddle voluntarily acts in the role of webmaster. This action would solidify the position. A motion was made to add the position to the By-Laws. The motion was seconded and the vote was unanimous. This position will be included in the Nominating Committees charter to find candidates for the next set of officers. However, volunteers for the position to relieve Steve Riddle as the interim "Webmaster" will be accepted at any time.

VP-45 History and Artifacts. Secretary Wally Massenburg opened discussion on what to do with the items that comprised the Squadron History. There is a great deal of historically significant stuff. He recommended that we engage the National Naval Aviation Museum, specifically, VADM Gerry Hoewing to find the point of contact to determine museum interest. Wally Massenburg has taken the action to pursue donating all significant historical record and artifacts to the museum.

Update on the Museum. President Buck Jones asked Mort Eckhouse to give us an update on the National Naval Aviation Museum in Pensacola, Florida. Mort indicated that there is an on-going restoration of a PB2Y-5R, an aircraft that Admiral Nimitz used for transportation during the way. They are currently building an eighty thousand square foot hangar, Hangar One, that will be dedicated in November, 2010. This hangar will include the fully restored P5M. The museum is also in the process of obtaining a MARS from Canada. It is one of two working (fire fighting) MARS still in existence. In addition, the museum is restoring an SB2C.

National Flight Academy. The National Flight Academy, which is adjacent to the National Naval Aviation Museum, will open to coincide with the kick-off of the Centennial of Naval Aviation in early May 2011. The academy will be for teenage students to promote aviation in general and Naval Aviation in particular.

<u>Centennial of Naval Aviation</u>. This coming year, 2011, marks the centennial of Naval Aviation. A calendar of events will be published I the January Newsletter. All members are encouraged to make events that are in their local areas.

VP-45 Association Philanthropic Activity. Following a discussion on what the VP-45 Association may be interested in providing donations; it was recommended that we support the Museum and/or the National Flight Academy. After further discussion, a motion was made to donate \$5000.00 to the National Flight Academy. Motion was seconded and passed unanimously. Mort Eckhouse volunteered to present the check to VADM Hoewing.

Squadron Flag. Member George Dragos informed us of some work he had done to seek information about obtaining a squadron flag. The squadron has no such Flag but thought they would pursue George's idea. George provided the e-mail from the squadron PAO:


VP-45 Association Banquet.





Rear Admiral Moran was born and raised in New York State. He is a graduate of Valley Central High School and holds a Bachelor of Science degree from the United States Naval Academy (1981) and a master's degree from the National War College (2006). ((Moran's operational Maritime Patrol and Reconnaissance Aircraft (MPRA) tours span all four MPR sites including his first in Patrol Squadron 44, Brunswick, Maine; department head, Patrol Squadron 45, Jacksonville, Fla.; command of Patrol Squadron 46, Whidbey Island, Wash., and command of Patrol and Reconnaissance Wing 2, Hawaii. He has deployed to Sigonella, Sicily; Rota, Spain; Lajes Azores; Keflavik, Iceland; Misawa, Japan; Diego Garcia; Masirah, Oman; Bahrain; and numerous detachments around the world. His other operational tours include flag lieutenant and Battle Group tactical watch officer for commander, Carrier Group 6, Mayport, Fla., completing a Mediterranean deployment aboard USS Forrestal and a subsequent deployment to the Caribbean aboard numerous cruisers as part of the first deployed staff in support of Counter Narcotics Operations. He has served extensively as an



instructor pilot in multiple operational tours and two tours with Patrol Squadron 30, the Fleet Replacement Squadron. ((Moran's shore assignments include: Patrol Wing 11, Jacksonville, Fla., as safety officer and assistant maintenance officer; the Bureau of Naval Personnel, Washington, as assistant Washington placement officer and assistant flag officer detailer; deputy executive assistant and executive assistant to commander, U.S. Pacific Command, Camp Smith, Hawaii, from July 2000 to July 2003; deputy director, Navy staff from July 2006 until June 2007 and as executive assistant to the chief of Naval Operations from June 2007 until August 2008. Upon selection to flag rank, Moran assumed duties as commander, Patrol and Reconnaissance Group in August 2008. (Currently, Moran serves as head, Maritime Aviation Programs on the staff of the chief of Naval Operations (CNO). In this capacity, Moran assists the director of Air Warfare (OPNAV N88) in the development, programming, and budgeting of warfighting requirements underpinning all training, maritime, and maintenance programs.

Commander Mike Doherty was born and raised in Glastonbury, Connecticut. He graduated with Merit from the United States Naval Academy with the Class of 1992, earning a Bachelor of Science in Economics. After graduation, he reported to the Naval Aviation Schools Command for flight training and earned his Wings of Gold in April 1995.

Following Fleet Replacement Squadron training at Patrol Squadron THIRTY (VP-30), he reported to Patrol Squadron ELEVEN (VP-11) stationed in Brunswick, Maine. After the squadron's final deployment to NAS Sigonella, Italy, and subsequent decommissioning, he remained in Maine and reported to Patrol Squadron EIGHT (VP-8) in July 1996. While serving as the Airframes Branch Officer and the Pilot Training Officer, he completed two additional deployments to NAS Keflavik, Iceland, Naval Station Roosevelt Roads, Puerto Rico, Howard AFB, Panama, and NAS Sigonella, Italy.

In May 1999, CDR Doherty reported to Patrol Squadron THIRTY (VP-30) as a Fleet Replacement Squadron Instructor Pilot in Jacksonville, Florida. He served as the Isochronal Scheduled Inspection System Branch Officer before finishing his tour as a Fleet NATOPS Evaluator and NATOPS Division Officer.
